and Jensen's alpha. The data extracted covers a 25-year time frame from 1995-2021 and is extracted in both monthly and annual time intervals. Using this approach, the research finds that one of the VC indices exceeds market risk-adjusted returns in terms of the Sharpe ratio and Jensen's alpha in net and gross returns. This finding contradicts the academic theory and should not be possible. The other VC index shows significant underperformance using both measures. To conclude, it is not possible to make any general statements using the present sample. In regard to VC index performance, therefore, it is suggested that further empirical research is conducted using a larger sample of VC indices while the outperformance of the TRVCINX is also investigated as it stands in contrast to the academic literature.
