On May 1, 2007, Mr. Manuel Sample presented himself for an initial examination and evaluation of his complaints arising from a motor vehicle accident that he was involved in on May 1, 2007.

The time was 7:00pm. Mr. Sample stated that he was the driver in a SUV which was stopped at a traffic light. According to the patient, the other vehicle involved was traveling at approximately 20-30 mph. He stated that the other vehicle struck his vehicle at the rear end.

Mr. Sample also reported that, at the time of the accident, the road conditions were clear and dry. In addition, he stated the damage to his SUV was mild due to the fact that the other car hit his trailer hitch. Damage to the other vehicle was moderate. He also stated that he did not see the accident coming, and therefore was not braced for the impact. Also, he was wearing his seat belt and had his shoulder harness on. On impact, neither the driver's or the front passenger's air bag deployed.

The SUV was equipped with headrests. He also noted that he had his head facing straight forward at the moment of impact. On impact the patient's body did not strike the inside of his vehicle. He stated that he did not lose consciousness during the accident. Mr. Sample reports that he and his wife went to Debra Medical Center the following day. They were given a prescription for Ibuprofen, an analgesic, and Toradol, a muscle relaxer and released. On release he was
