(1) Mold: a type of fossil formed when a shell or other hard part of an organisms dissolves, leaving an empty space in the shape of the part; (2) Cast- type of fossil formed when a mold becomes filled in with minerals that then harden; (3) Petrified fossil – a fossil formed when minerals replace all or part of an organism.**
7. What parts of organisms are most likely to become preserved as a fossil? **Hard parts – shells, bones, teeth.**
8. What parts of an organism can not be preserved as a fossil? **Cells, tissues etc.**
9. Name the two methods of dating fossils and explain each.
(1) Relative Dating - a method to compare the ages of two fossils based on the layer of rock in which it was found.
(2) Radioactive Dating- a technique used to determine the actual age of a fossil on the basis of the amount of a radioactive element it contains. Scientists compare the amount of the radioactive element left in the sample to the amount of the element that it breaks down into.
10. What 5 types of evidence do scientists use to prove that organisms evolved from a common ancestor?
Fossils, Similarities in early development, similarities in body structure, DNA, and protein structure;
