A capital investment is defined as an outlay that is expected to result in benefits in the future. Capital budgeting is the process of selecting capital investments.

Capital budgeting is concerned with manager's decisions about capital expenditure or capital investments. It is about whether, when and how to spend money on capital projects, or in other words, it is about evaluating investment opportunities. Such decisions are important ones for the firms involved because other large sums of money are committed in an irreversible decision, with no certain knowledge of the future benefits.

The cornerstone of all investment appraisals is the weighing of benefits against costs for each individual project, so measuring its worthwhileness. If this measurement is done badly, it can hamper a firm's growth and employment prospects for years to come, and may lead to an inability to attract capital.

Financial institutions and individual investors provide private sector firms with capital in the expectation of a reasonable rate of return. If a firm invests that money in projects that do not yield a reasonable return then investors will be wary of that firm in the future. If the firm is a public sector organization, the appraisal of capital expenditure on projects is equally as important as appraisals done by private sector organizations. All organizations need to ensure, wherever possible, that in any
